# 6.2 ACTION: Alternate Science Standards (DLM-EEs) Revision

**Committee Discussion:** The Utah State Board of Education has a contract with the Dynamic Learning Maps (DLM) Consortia to develop and assess Alternate Achievement Standards, titled the Essential Elements (EEs). States must include students with disabilities in their accountability systems and may develop Alternate Achievement Standards and an aligned assessment for students who have the most significant cognitive disabilities (IDEA Section 1414(d); R277-750).

The EEs are not "separate" or "distinct" from the Core Standards but simply reduce the depth and breadth of the Core Standards so that they are accessible to students with significant cognitive disabilities. The DLM Consortia revises the Standards every few years based on the revision of Core Standards in member states and the data collected from member states about the ability of students to access and make progress in the EEs and to demonstrate progress and proficiency on DLM assessment.

**Committee Action:** Member Green made a motion that the Committee approve the DLM alternate achievement science standards revision and forward to the Board for final approval.
