The purpose of the hearing is to consider proposed amendments to the Site Development Master Plan for the Royal Holladay Hills Redevelopment area (aka Cottonwood Mall Redevelopment Area, 2007) within the Regional Mixed-Use zone (R/M-U). The proposal, made by the property owner, KMW Development, is to include project signage details for the development. As indicated by the SDMP (pg. 17), project signage criteria is anticipated to be added to the small area master plan as an appendix

The proposed amendment is available for public inspection on the City's website www.holladayut.gov and at the Community Development Dept during normal business hours.

AMENDMENT PROPOSAL:

Royal Holladay Hills Site Development Master Plan Project Signage Criteria

SUMMARY

As anticipated and directed on page 17th of the Site Development Master Plan (SDMP), property owner and applicant, Steve Petersen (Applicant), proposes to include Project Signage Standards as an appendix to the SDMP

REQUEST

The Royal Holladay Hills redevelopment site, currently in the R/MU zone, is subject development details provided in the 2007 Site Development Master Plan (SDMP). Sections of the SDMP are designated to provide guidance on project signage locations.

Since the adoption of the 2007 SDMP, the criteria for signage is the last element that remains to be adopted. The Applicant has refined signage massing, locations and design in order to create standardized signage which is customized to the development itself, rather than the city in general.

The proposal can be categorized into various types; Development, Tenant, Directional and Parking signage. None of the sign types feature electronic type message boards, but rather internally illuminated cabinet style placards with decorative lighting features, unique to the Royal Holladay Hills theme.

REASONING & PURPOSE

The overall intent of this amendment is to propose missing signage standards.
