Utah Code § 54-17-302(5) requires the PSC to issue an order within 120 days of Rocky Mountain Power's filing of its Application, unless the PSC determines additional time to analyze a significant energy resource decision is warranted and is in the public interest. The parties at the scheduling conference unanimously stipulated that, here, additional time is warranted and in the public interest. Based on their representations and the PSC's review of RMP's filing, the PSC finds the additional time to adjudicate this matter that the stipulated schedule affords is both warranted and in the public interest.

DISCOVERY

Discovery turn-around times shall be 14 calendar days until February 13, 2026, and 7 calendar days thereafter. Parties shall serve discovery requests and responses on applicable parties by electronic mail. In the event a document produced in response to a discovery request cannot reasonably be transmitted by electronic mail, the party disclosing the document shall provide an electronic copy of the document on CD (or, if an electronic copy is not available, a paper copy).
