2. Animal Control: Warning letters going out to concerns are being effective.
3. Fire Dept.-Chief Shawn Robison: working on tender truck replacement through the state.

1. Approval is finally given for inspection of the new speed limit signs on state street so that they can be connected to power.
2. It was decided to hold a community volunteer cleanup night on Wednesday 15th starting at 5:00 pm to tidy up fire hall and town hall properties. A dumpster will be brought in for that purpose but residents will be able to add to it afterwards.
