3. <u>Beacon Hills</u>, (9 single-family dwellings), 756 30th St Regarding the Preliminary Group Dwelling and the Private Subdivision, Petitioner Brandon Stoddard and partner, both longtime residents of Ogden City, were eager to provide the opportunity for owner occupied single-family homes with this project.

Assistant Planning Director Joseph Simpson stated that staff supported the plan with some conditions such as the suggested amenities, addressing the building materials discussed, adding garbage enclosures, adding a road for access, etc.

4. Public Hearing Zone Change, R-4 to R-5, 211 Patterson St

Petitioner Tim Price with the Ogden Housing Authority stated they were seeking the rezone to add a housing unit for foster care and homeless youth needs. With approval for 25 units, they will qualify to get help with tax credits.

Assistant Planning Director Joseph Simpson displayed slides and said the single lot plan supports the General Plan and that staff recommended approval of the proposed rezone.
