



## CANYONS SCHOOL DISTRICT MINUTES OF BOARD OF EDUCATION MEETING

**The following minutes are a summary of the October 28, 2025, Canyons Board of Education Public Hearing.**

**1. Public Open House – 6:00 p.m.**

A public open house was held with information displayed for patrons to review regarding the boundary study.

**2. Presentation/Patron Comments – 6:30 p.m.**

Mr. Wilcox reviewed information regarding the boundary changes and school consolidation/closures. The District is studying boundaries to maintain optimal class sizes and a full menu of academic opportunities for every child. Elementary enrollments have declined and are expected to continue to decline, driven primarily by slowing birth rates and soaring housing prices.

The District's funding is based on state-legislated formulas. The largest funding source is the Weighted Pupil Unit (WPU). For every student enrolled for 180 days in 2024-2025, the District will receive \$4,674 per student from the state for the 2025-2026 school year. With an estimated 659 fewer students for the 2025-2026 that equals \$3.2 million less funding for the district in 2026-27.

Mr. Wilcox reviewed where the District has been preserving funding for schools through absorbing district level administrative position, reassigning district office employees to work in the schools, delaying technology and equipment replacements to extend their use, placing a hiring freeze and prioritizing positions for employees if schools are consolidated. Canyons has been subsidizing small schools to maintain staffing. Continuing to do so long term pulls funding away from other schools affecting class sizes, electives and student support elsewhere.

Combining schools makes it easier to maintain optimal class sizes and a full menu of academic opportunities for every child.

East Central Region: Granite, Park Lane, Lone Peak and Willow Canyon Elementary schools. Park Lane and Granite Elementary would be combined and one of the schools would close. A portion of Granite Elementary's southern boundary (about 40 students) would transition to Lone Peak Elementary. Proposal number one would change a portion of Granite Elementary's boundary (West of Eastdale Drive and North of 9800 S) to transition to Willow Canyon (about 50 students). A second proposal would have this area remaining with the Granite/Park Lane consolidation.

To align with middle school feeders, a portion of Granite Elementary (East of Highland Drive and North of 9800 S.) would feed into Eastmont Middle School to align with Jordan High School's boundaries. The region of Granite Elementary that is being considered for transition to Lone Peak Elementary would attend Indian Hills Middle.

The District commissioned an independent study to examine the fitness of existing facilities for increased traffic flows, and transportation needs and will be ready to present findings at an upcoming board meeting.

Preschool and Special Education units are currently under review to explore where to locate early childhood classrooms and SPED units to best serve families and balance enrollment.

School rebuilds are under study, but decisions will depend on many factors such as construction costs, interest rates, enrollments, building age and condition, debt repayments, taxable values of property, etc.

School choice permits and proposed boundary changes to accommodate the school-transfer request for students impacted by boundary changes or school consolidations were reviewed.
