CJC Program Update –

- NCA Accreditation Standard 3 (F): Forensic Interview
- Cases meeting the CAC case acceptance criteria, as outlined in the MDT protocol, have forensic interviews conducted at the CAC, or through a secure tele-forensic method, a minimum of **75%** of the time.

- Primary victims served between July 1, 2024, and June 30, 2025 with either sexual or physical abuse allegations in CMS.
- % of SA victims served calculated based on total of SA FIs and medical exam only
- FIs for cases with both PA and SA allegations are included in the SA FI number
- Cases with "Other" allegation listed, but a SA allegation noted are included in the SA FI total. Examples: sexual exploitation, lewdness, dealing in harmful materials, etc.

FI Data Cont..



Tracking: Data metrics to capture accurate data.

CPS- State office and SLVR providing AG's office with data

- Case Criteria- Unable to Complete/Unable to Locate Cases
- Cross Reporting and case assignment

Law Enforcement- Data Requests on SA cases ages 3-17

- SA – all kinds of related crimes (sexual exploitation, lewdness, dealing in harmful materials, etc.)
- Physical Abuse

MDT Protocol Follow-Up:

Case Acceptance Criteria for bringing a victim to the CJC:

1: There is an allegation of abuse of a child, teen, or vulnerable adult

- Youth ages 17 and under
- 18-year-old youth who are still in high school
- Vulnerable adults that were sexually or physically abused per [U.C.A. § 76-5-111\(1\)\(s\)](#)

2: Allegation must be a crime of the following types:

- Child sexual abuse, sexual exploitation
- Rape, sexual assault of all minors 17 and under, or 18 in school
- Child physical abuse - with current injury or danger of ongoing harm
- Lewdness, Voyeurism, Pornography, Sexual Exploitation or similar
- Child abductions or kidnappings
- Child witness to homicide

WHO: DCFS, LE, CJC, FI, CFS, VSC

DCFS and LE will both attend the interview at the CJC. A CJC FI can be available for consultation or to conduct the interview.

- DCFS and the LE detective will coordinate a **joint response** to conduct victim interviews:
 - Scheduling the date and time of the CJC interview with the child
 - DCFS and LE will determine the need for a CJC FI prior to scheduling at the CJC
 - Determine who will conduct the interview (LE will wear soft uniform or plain clothes if conducting the interview)
 - Attend and observe the CJC interview session
 - Collaborate CJC staff on case information
 - Participate in Pre and Post parent meetings
 - Ensure the safety of the child victim
