Mayor Jed Maxwell called the Public Hearing to order at 7:00 pm, at the Salina City Hall welcomed everyone present.

Public Hearing: To receive comments on Proposition 12. Reauthorize an existing 1/10th of 1% sales tax to fund parks and recreation programs in the North Sevier communities. This is not a new tax but a continuation of the current Parks and Recreation (PAR) tax. **Mayor Maxwell** reviewed Proposition 12 and asked for public input. **Brent Beach** spoke about the importance of the PAR Tax for Salina City Rec.Center. **Kevin Mickelsen** motioned to close the public hearing at 7:00 pm. **Jon Maxwell** seconded. Motion carried 4 to 0.

Mayor Jed Maxwell called the City Council meeting to order at 7:00 pm. led the pledge of allegiance and Jon Maxwell offered the opening prayer.

Mayor Jed Maxwell: Review budget **Mayor Maxwell** asked Councilmen to review the budget and reach out to department heads with any questions.

Approval of donations Mayor and Council discussed the donations which were presented at the previous Council meeting. The first donation is for the Food Bank, and the second donation is for Kathleen Green, regarding a trophy for an event she is hosting at the Blackhawk Arena. Approval of Gopher control at the Cemeteries & Park Jorgen Mickelson Maintenance Supervisor received a bid in the amount of \$5,000.00 to address the gopher issues at the cemeteries and park. Approval of tree removal on 200 North Jorgen Mickelson stated a tree located within the Salina City easement at 200 North fell and damaged a car. The homeowner is requesting that Salina City remove the tree to prevent future issues. **Mickelson** received a bid from S&S Tree Service in the amount of \$1500.00. Mayor and Council determined that since the tree is on Salina City property, it should be removed. **Brad Allen** stated the previous homeowner requested not to have the tree removed. **Kevin Mickelsen** motioned to approve the tree removal at 200 North for the bid amount of \$1500.00. **Randy Christiansen** seconded. 
