A. Administrative:

1. President Williams called the meeting to order at 7:30PM
2. President Williams led the Pledge of Allegiance

Citizens comments:

Jerre Holmes- Commended the board and Superintendent for their work in moving forward with the bond. He said the only reason not to bond is the higher taxes. However, there are many reasons to move forward. Safety, our roof system is too heavy and no one wants to wait for us to have an earthquake. The building is worn out and is costing a lot, it is very inefficient. The new roof would cost a lot of money and would only last a few years. He said that this building wouldn't pass an inspection. No one wants kids in modules while we retro fit it. No one knows when or how soon there growth will be, but we only have 1 classroom left open. There is no room in this building. Mr. Holmes said that the most important reason to build is for the kids. He applauds the board for standing for all kids.

Karen Pace- Ditto to Coach Holmes. Karen mentioned that she and her husband have been to every meeting except 1. This auditorium should be full, under 50 people is about what we have at each meeting, and under 20 today. We need a new school. No one wants more taxes, but we owe it to our students. The board bought the land several years ago. If we keep waiting it will only get more expensive. What will happen is our board will be forced to make a hard decision, and the bond will be more expensive with a higher interest rate. I will be voting for the bond, and the board needs to be commended for all their hard work.

Zory Clark – Said the county hasn't done us any favors. Just wonders if we have contingencies in place if the costs continue to rise, have we tried block grants. He's been out of town, and has some questions, but wants to advocate for the bond. He is disappointed by the lack of attendance.
