The NFSSD Fall Community Meeting 2025 was brought to order at 7:00 p.m. by Scott Hart. This meeting was hosted both in person and remotely. A presentation including a slide show was given by Chairman, Dr. Stephen Minton. Video of this presentation will be made available at the District website https://www.northforkdistrictutah.gov/ and a recording will be available through the Utah Public Notice Website.

Dr. Minton presented on various District challenges including fire services, water management, and the need for a new fire station, while highlighting financial considerations and fee structures. The community discussed forming a committee to address fire prevention issues and explored potential funding solutions, with emphasis on the need for broader community involvement and transparent fee structures.

A discussion "Q&A" took place after the presentation, community members gave their input regarding District matters and the Board answered questions from the public.

Suggested next steps:

- The Board to restructure fire fees to make them equitable and fair for all property owners.
- The Board to continue negotiations for a piece of land for the new firehouse.
- The Board to reevaluate the firehouse design, size, and materials to potentially reduce costs.
- David Parker to chair a committee to negotiate with Utah County for increased funding beyond the current \$180,000.
- The Board to form a Fire Committee with community representatives to provide input on the firehouse project.
- The Board to improve communication and transparency with the community regarding the firehouse project.
- The Board to incorporate wildland fire revenue into the financial plan for the new firehouse.
- Community members to submit recommendations and suggestions regarding the firehouse project and funding options.
