1. Strategic Planning
Superintendent Shank and Woolpert Inc presented the demographic study which addressed future projections for the county's student enrollment. Overall, births have declined with exceptions of 2022 and 2024. The ten year projections show the trend of enrollment relatively steady with minor changes within the 10-year span. Considering this, Supt Shank recommended not making any school or boundary changes for the 26-27 school year allowing the District to monitor future enrollment.

1. Independent Auditor Report from Gilbert and Stewart for FY25
Independent Auditor's report
LEA Year-End Financial report

Business Administrator Jackie Allred presented an overview of the Fiscal Year 2025 Annual Comprehensive Financial Report. The District remains to be solvent in all of the governmental funds and shows an increase in the Net Position. Instruction and Student Support account for 68% of General Fund expenses while local property taxes represent 33.85% of General Fund revenues. Capital building projects continued through FY25 showing expenses using State funded capital grants. Excluding capital projects, the expenditure per pupil was \$16,887.

James Gilbert, external auditor from Gilbert & Stewart, reported that the District did not have any findings and all state compliance requirements were met.

F) REPORTS

1. Principal

Green River High Principal Kayce Maes-Fluckey presented the school's theme this year as 'Celebrate' with their leadership, curriculum, extra-curricular programs, and participation. GRHS Student Council is tracking and rewarding students' participation with regular celebrations. The Dignity Index has been introduced to strengthen the school culture where educators are leading daily lessons with a 'Daily Dignity'. Increasing academic proficiency is a constant goal with data driven instruction and targeted interventions. Their educators are implementing the Pillars of the district's Portrait of a Graduate. Brennan Bigelow explained that the Ag and FFA programs are moving forward and focusing on the irrigation system with students doing the labor. They have developed relationships with the local conservation district which has provided them with seed and conducted soil tests. They are learning to problem solve with soil and last year's garden.

All of the students are involved in many programs and show leadership in all of the activities and curriculum that is offered. GRHS also coordinates with Emery High to provide virtual academic opportunities.

2. Superintendent

Superintendent Shank reported on the following items:

1. Recognition of the EHS Cross County Girls State Champions!! There will be an official recognition at next month's meeting.
2. The Lt Governor will visit the District on the 17th and will be visiting Ferron Elementary to review the successful third grade reading performances over the past five years.
3. Adult Education program has increased the number of graduates and has implemented 4 cohorts including a program in Green River in the last two years.
4. An additional Strategic Planning is scheduled for tomorrow evening at Ferron Elementary.

3. Business Administrator

The annual LandTrust Training for Board Members was conducted. Ms. Allred also stated that the District has

received a generous donation from the Larry H & Gail Miller Foundation of \$2,500 for Sub for Santa purposes.

4. Board Member Committee

Student member Byron Roundy works with the IT dept to help GRHS's technology function on a daily basis. He also participates in student council and the e-sports program has plans to eventually stream the competitions and move to the auditorium. The Journalism class is also working on starting the commentating of broadcasts at home games.

Kenzi Guymon attended the district and USBA policy meetings, community councils at San Rafael and Ferron elementary, the capital outlay walk through at those schools, the fire/reunification drill at Ferron. Tomorrow is the Thanksgiving dinner at Ferron and also the strategic planning meeting.

Neal Peacock attended the Cottonwood Elementary with new members, USBA policy meeting, two veterans programs, and the Canyon View strategic planning committee.

Royd Hatt attended two community councils also with new members and the audit committee meeting.

James Winn attended the USBA legislative committee planning Day on the Hill, JLC meeting where it was voted to support Sen Owens LandTrust bill, community council meetings at Canyon, Cleveland, and Huntington elementaries, and the audit committee meeting.

Byron Roundy indicated that there were GRHS students expressing desire to participate with sports without a full schedule. He will work with school administration on the follow up steps.

Doug Johnson recognized Adele Huntington and her many years of service to the District. Also thanked for everyone who has stepped up for the safety roles in the schools. ECSD is far advanced than many other districts in providing the required safety mandates.
