### MEETING MINUTES

1. Board Members unanimously approved the July 2025 Minutes. Motion by Board Member Nilson, second by Board Member Stewart-Johnson.

### NEW BUSINESS

2. Park/Parks Maintenance- No representative from Parks at the meeting
3. Sports- Sport Coordinator Victor gave a sport program update discussing the participation numbers of Fall programs.
  - a. Adult sport programming has dropped for different reasons but should start to increase again in 2026. It is anticipated that staff offer the following programs in the future: Turkey Bowl-flag football (depending on park space available), Adult Basketball, (dependent on adult officials), Sand Volleyball (available with new courts completed at Centennial Park)
  - b. Youth Sports are trending upwards with participation with each sport
  - c. Board Member McGary asked if Santaquin provides an adult Site Supervisor at each site. Sport Coordinator Victor said they do have an adult 18 and over scheduled each night as a site supervisor. The exception would be when there is a single field located off site. Park space access is currently directed by Park staff.
  - d. Future youth sport programming ideas were discussed including Lacrosse, Tackle Football. New program start up is dependent on site availability, equipment storage, programming space in accordance to existing programs being offered, budget for equipment start up.
  - e. Board Member Stewart-Johnson reminded the need for personal equipment to be funded by individual families. This helps them be committed to the sport.
  - f. Future programs can be reviewed and discussed. RAP Tax is a great tool to help fund new sport programs.

- g. Council member Del Rosario talked about potential grass expansion of Harvest View Sports Complex. This is dependent on budget and funding priority by City Council. This is currently not budgeted this fiscal year.
- 4. Upcoming Fall Events-Recreation Coordinator Backman gave an update of Fall Special Events scheduled.
  - a. October Holiday events noted. All events are listed on our website.
  - b. Golf Tournament filled all 15 team spots and went well.
