



# CERTIFICATION OF THE 2025 GENERAL MUNICIPAL ELECTION RESULTS, HELD NOVEMBER 4, 2025

I, Amanda Gardner, Recorder for the Town of Altamont, County of Duchesne, State of Utah, do hereby certify that the following is a full, true, and correct abstract of the statement of votes cast for the General Municipal Election held on November 4, 2025.

## SUMMARY

With a total of 117 registered voters in the Town of Altamont; 55 ballots cast; and 47.86% voter turnout, the following are the results of the 2025 Municipal Election for one 4-year term Mayoral Seat, two 4-year term City Council Seats and One 2-year term City Council Seat.

### **In the race for Altamont Mayor (4-Year Term):**

Philip Scot Allen received 51 votes (92.73%)

### **In the race for Altamont Town Council (4-Year Term):**

Michael Howard Foy received 49 votes (89.09%)

James Edward Helms received 41 votes (74.55%)

### **In the race for Altamont Town Council (2-Year Term):**

Chrisopher David Baca received 11 votes (20.00%)

Russell Roy Sorensen received 44 votes (80.00%)

Resulting in Philip Scott Allen being elected to fill the one open seat for Mayor, Michael Howard Foy and Jason Jaems Edward Helms being elected to fill the two4-year term open seats for Town Council and Russell Roy Sorensen elected to fill the 2-year term open seats for Town Council .
