

MANTUA TOWN 2025 MUNICIPAL GENERAL ELECTION

The Board of Canvassers of Mantua Town, Utah, met at the Mantua Town Hall, 409 N Main St., Mantua, Utah at 6:30 p.m. on Tuesday, November 18, 2025 to conduct a canvass of returns from the 2025 Mantua Town Municipal General Election pursuant to Utah Code Unannotated 20A-4-304. Clerk Sherita Schaefer conducted the canvass. A cursory review of the ballot tabulations was made. The results of the canvass are attached.

Sherita Schaefer stated there were 568 ballots cast. One ballot was received after Tuesday, November 4th, which was too late and not counted. The number of ballots counted on election night was 567 for an election night percentage of 64.14.

There were no voted provisional ballots. (Provisional Ballot Report attached). After counting the valid ballots, the percentage of ballots counted was 64.25 percent, a total of 568 ballots.

Sherita Schaefer reviewed the audit procedures with the Board. She said Box Elder County was required to audit 255 ballots and 88 signatures, which were randomly selected by the Lt. Governor. The 255 ballots selected were compared with Cast Vote Record in Election ware. She reported that the votes matched. The 88 voter signatures selected were compared with the signatures on file in Vista. She reported that the signatures matched. Election Official, Sherita Schaefer, followed all the noticing and reporting required by Utah State Code.
