Southern Utah Heritage Choir

Southern Utah Heritage Choir is seeking \$50,000 for operating. The Board agreed to consider them

for funding.

Southwest Symphony

Southwest Symphony is seeking \$75,000 for operating costs. The board agreed to consider them for funding

St. George Children's Museum

St. George Children's Museum is seeking \$35,000 for operations. The board agreed to consider them for funding.

St. George Dance Company

St. George Dance Company is seeking \$25,000 for operating & a special event. The board agreed to consider them for funding.

St. George Interfaith Choir

St. George Interfaith Choir is seeking \$6,000 for operating and capital. The board agreed to consider them for funding, but is requesting more information.

St. George Musical Theater

St. George Musical Theater is seeking \$100,000 for operating costs. The board agreed to consider them for funding.

Glen Webb informed the board that two applications were received past the deadline from United We Pledge and Desert Strings. The board discussed the circumstances presented by the applicants for submitting past the deadline. It was decided that the board would not accept the applications at this time.
