CIVCO-MAIN STREET ROAD PROJECT UPDATE-TROY OSTLER

Mayor Cooper stated she was turning the time over to Troy Ostler to give an update on the main street road project. Troy Ostler stated that what they have left on the project is the two waterways on Center Street and Main Street and how to eliminate the big dips. He discussed the two options to fix the dip and still be able to divert the water and they need to finish painting the parking stall lines along main street. Troy Ostler stated they are going to watch the trench settlement over the winter, and the reason why is as they paved it, they got some settlement, which is the reason for the little bumps as you drive down Main Street. They are going to keep the contract open with the contractor and not close the job until they can evaluate it in the spring and decide what might have to be done with that and they have adequate budget to repair anything that may settle over the winter along with repairing the waterways. Alan Allred asked about the contractors coming and cleaning out the valve cans. Troy Ostler replied that they haven't. Michael Fenn asked about cutting the road down where the big dip is.

J-U-B ENGINEERING-CHANGE ORDER #6 AND MAIN STREET WATER PROJECT UPDATE

Mayor Cooper stated she was turning the time over to Greg Williams from J-U-B. Greg Williams stated that there should be a change order in the packet for the water project. What we need to discuss today is the change order that will use up the contingency on the water project. The reason for needing the contingency money is they started hitting unknown water lines in April. This change order is for all the extra costs throughout the project, and the increase is \$64,012.00. Mayor Cooper asked where the water could be coming from that is still feeding the old water line on Main Street. Greg Williams stated he thinks its coming from a valve that is not shutting off all the way, but they still need to test that theory.

Alan Allred stated he is training the other guys on the basics but isn't doing any classwork with them.
