ORDINANCE NO. 10-29-2025 O1

**AN ORDINANCE AMENDING TITLE 03 REVENUE AND FINANCE, CHAPTER 03.30
“COUNTY FEE SCHEDULE” IN THE UINTAH COUNTY CODE**

WHEREAS, Uintah County is authorized under Title 17 Chapter 53 of the Utah Code Annotated (1953, as amended) to adopt ordinances to promote the peace, health, safety and welfare of the county inhabitants; and

WHEREAS, efficient and economic administration of county government is enhanced by the adoption of a uniform fee schedule; and

WHEREAS, the transparency of said fee schedule is enhanced by formally adopting it into the Uintah County Code; and

WHEREAS, the County may, from time to time, amend the duly adopted fee schedule; and

NOW THEREFORE, the County Legislative Body of Uintah County ordains as follows:

SECTION I. Title 03 "Revenue and Finance" Chapter 03.30.010 "County Fee Schedule" of the Uintah County Code is amended as set forth in the attached schedule, incorporated hereto by reference.

SECTION II. EFFECTIVE DATE. Changes to the fee schedule shall take effect fifteen (15) days after enactment. A copy will be deposited in the Clerk-Auditor's Office and a publication will be made in a newspaper having general circulation in the County, as required by Utah Code Annotated §17-53-208.
