A. Report: Laurie H reported that the council passed the Nuisance Ordinance text amendment regarding manure, but they had an issue with part of the ordinance that was already in place and asked the commission to look at whether that section still needs to be in the ordinance.

Zoning Administrator/DRC Report – Kenny Funk:

A. DRC: Kenny F

- A very messy boundary adjustment was presented which will require some work to straighten out.
- David Yates submitted a new proposal for the Harper Haven subdivision, but it still has some issues that need to be addressed.
- A driveway permit was requested in Savannah Heights.

DISCUSSION ITEMS:

A. Nuisance Ordinance 4-2-2-B: The city council did not like section 6 of this code. After discussion the commission felt that both section 6 & 9 could be removed from the code. A public hearing will need to be held regarding these amendments to the code.

- B. Fence Ordinance & Permit Anna & Kelli After presenting a few examples from other cities it was found that the commission liked Alpine's best and Anna & Kelli were asked to make a permit similar that included Honeyville City's information.
- C. Shooting in City Limits Laurie Due to several complaints the Mayor has asked the commission to look at ways to restrict shooting within city limits. The commission felt that since Honeyville is very rural, it would be difficult to state that no shooting be allowed within the city. They suggested having regulations pertaining to the different zoning areas.
- D. Sidewalks Laurie After reading the current ordinance, the commission felt that there were no issues that needed to be addressed with the current code.
