**A. Bryce Canyon Recreation Association (BCRA) RAP Tax Use Application:** Lance present to discuss the application. Application was emailed out for review. Requesting \$25,000.00. Have been operating an ice rink since 2008. Ruby's Inn does sell packages for the ice rink. Brings in many youth groups. Ebenezer's is working on marketing winter activities, and it causes issues with the ice rink area utilizing the food serving area. BCRA requesting to purchase a shed/building to move everything outside. Will use Ebenezer's bathrooms still. This will help keep the rink open more when there are conflicts with Ebenezer's. The building plans have been approved through Fire Chief Harris, and it meets fire code. Will be a mobile shed/building and not permanent, will be placed on the Ebenezer's asphalt.

**B. Shuttle Building Enhancement Design Project:** Project is ongoing. At a standstill, with working on the elevations with the lawns. Pouring concrete this morning. Work on landscaping next week. Should be complete end of next week. They will be fined if they are not complete, per the contract. There was no rebar in concrete pour this morning, concrete company stated it was not needed in plan with the size of the concrete. Tom reached out to engineer to clarify if rebar was needed and will let Tanner know. It was reported back that the concrete specs did not require any rebar.

**C. Town Park Project:** Plans complete. Work on the next phase- receive estimated cost of project. Discussion on moving soccer field? Will keep it as planned.

**D. Tim Leech – Christmas Concert Donation:** Tim Leech present. Council initially concerned with donation amount requested. Would like to see hard numbers and a presented sponsorship plan. The original plan was to pay \$5000.000 to Nashville Tribute Band, which is a nonprofit and \$5,000 would pay for Ben Gallaher. Jean discussed marketing for the concert. The concert is sold out. These concerts promote the venue. Ben Gallaher will be filming in the area and will be promoting. So far, they have spent \$3,000.00 on radio ads, and social media. Sponsorship ads will be on the big screen on the stage. Will also receive tax money back through room rentals, and sales in the city. They will be opening general admission tickets, without dinner soon. May run more radio ads promoting that.
