Planning Director Brandon Larsen stated there was no new information from the Work Session to review. He explained that this request pertains to the Master Development Plan and Agreement for Lower Hidden Valley. Two parcels, 58:040:0623 and 58:040:0624, were partially considered during the Master Development Plan process but were never rezoned. The applicant contends these parcels should have been rezoned along with the rest of the Lower Hidden Valley MDA.

The applicant provided a receipt for a past rezone application, claiming the previously paid fee should cover consideration of these parcels. Staff clarified that the fee was for the broader MDA area, not specifically for these two parcels. Regarding the current request for a reduced fee, Staff noted there would be little time savings or reduction in workload, as fee reductions are typically granted only when minimal staff effort is required. The only potential justification for a reduction would be if it could be shown that the applicant had already paid for Council consideration of these parcels and the action was never completed.

Senior Planner David Stroud presented the proposed code amendments to the 16.20 Preliminary Plats and 16.25 Final Plats.

For 16.20 Preliminary Plats, the proposed amendments will align with State Code 10-9a-604.1, which prohibits the legislative body from approving plats with single-family, two-family, or townhome units. The proposed amendments also update noticing requirements, with the City now sending postcard notices and billing applicants instead of requiring stamped envelopes.

For 16.25 Final Plats, the proposed amendment includes code clean-up and new standards, such as requiring plats to note the zone under which they were reviewed and prohibiting cardinal directions in street names to avoid address confusion.

Senior Planner David Stroud presented that this ordinance amends Eagle Mountain Municipal Code 17.100 Site Plan and stated that the proposed amendments contain two primary changes. The first is regarding how access onto a public street from a parking lot or private drive is measured. This was reviewed by the Planning Commission several months ago, and when reviewed by the City Council, the body requested clarification.

The second amendment adds administrative approval by Staff to review and approve minor site plat amendments. The proposed Code lists items that would qualify for administrative site plan approval. If determined a proposal is not minor in nature, the request will be processed as a standard site plan with review by the Planning Commission and final approval by the City Council.

City Attorney Marcus Draper and City Recorder Gina Olsen presented that under current city code, Youth Council members are elected by their peers. This process has run into difficult logistics and has not been functioning as smoothly as would be desired. The proposal would give authority to the Mayor to appoint the youth council with advice and consent of the City Council. Other positions, such as committee members or department heads, would be filled by appointment or with the approval of the City Manager.

Youth Council Board Chair Jessi Call and Youth Mayor Benjamin Bird addressed the Council with updates and advocated removing the elections for Youth Council.

Councilmembers further discussed the clarification of the language surrounding the current city code.

- *In 2.45.010 Section C: Change from "members are appointed to Youth Council by the City Manager" to "members are appointed by the Youth Council Committee of Advisors".*

- 16.A. RESOLUTION - A Resolution of Eagle Mountain City, Utah, Approving the Disposal of 0.156 Acres of Designated "Significant Real Property" (Utah County Parcel #49:601:0080) Pursuant to EMMC 3.30.060 and 3.30.070, and Establishing Terms of the Disposal

City Recorder Gina Olsen presented the Land Disposal application from Samarah Moody. The disposal would address encroachments and improve the layout of residential lots, with consideration of water usage implications.

The application was submitted by Samarah Moody requesting disposal of Utah County Parcel #49:601:0080. The applicant has executed a written cost acknowledgment per EMMC 3.30.070. All applicable departments have reviewed the request and have no concerns with the disposal of the property. No utilities are located on the property that is being considered for disposal.

Councilmembers discussed the two disposal options with this application which is as follows:

- Option 1: Fence Line Realignment (straightening lot lines consistent with the fence line to the west)

- Adjust lot boundaries using the existing rear fence line, addressing current encroachments and improving boundary clarity. With this option, staff recommends the following scenario:
 - Lot 68: increase by ~0.04 acre (≈1,742 sq ft), requiring +0.12 acre-feet of water
 - Lot 67: increase by ~400 sq ft, no additional water required
 - Lot 66: increase by ~184 sq ft, no additional water required
 - This option involves minor modifications and limited water impact.
- Option 2: Full Disposal of Parcel 49:601:0079 + Portion of Parcel 49:601:0080
 - Dispose of the entirety of Parcel #49:601:0079 and part of Parcel #49:601:0080, dividing the land among adjacent property owners along their existing lot lines.
 - Impacts 11 lots.
 - Each lot would receive between 0.02 to 0.08 acres.
 - 11 lots would require additional water ranging from 0.13 to 0.26 acre-feet.
 - To maintain consistency with the new rear lot line, this option must be processed as an all-or-nothing scenario.
 - Sufficient open space remains under parcel 46:614:0095 to allow for an east-west trail corridor.

- *It is required that all fences are on the correct lot line or the lots are to have no fence within 6 months of recordation.*
- *The water requirements for each parcel are fulfilled with the purchase of the parcels as deemed appropriate by staff.*
- *The full land disposal application and process must be finalized in six months (February 19, 2026).*

Communications Manager Tyler Maffitt presented an overview of the Recreation, Arts, and Parks (RAP) Tax, a voter-approved, local option sales and use tax of 0.1% that can support cultural arts programs, recreational facilities, parks development, and related community projects. He explained that if approved by voters, Eagle Mountain City would impose the tax on applicable goods and services, generating approximately \$0.10 per \$100 spent, with projected annual revenues of around \$600,000 depending on growth and local spending trends.

Staff noted that funds would be managed by a dedicated RAP Tax Advisory Board, appointed by the Mayor with the advice and consent of the City Council, which would evaluate proposals and recommend funding priorities. Tyler Maffitt clarified that the resolution under consideration does not impose the tax but directs that the question be submitted to voters in the 2025 General Municipal Election, as required by Utah law, ensuring public input and accountability. A letter of intent has been submitted to the Utah County Commission, and next steps include coordinating with the Lt. Governor's Office on a Ballot Proposition Number and soliciting arguments for and against the proposal. Adoption of the resolution would provide residents the opportunity to determine whether to invest in local amenities through this targeted, voter-approved funding mechanism.
