Mayor Pro Tempore Wright called the meeting to order at 4:00 PM. He noted Mayor Westmoreland would not be in attendance due to illness. He also noted that Councilmember Jared Gray would connect electronically as his cellular service allowed.

1. DISCUSSION AND INFORMATION ITEMS

1.A. DISCUSSION - Annexation Policy Plan

City Manager Benjamin Reeves explained that as part of the General Plan Update, the City needs to reevaluate the Annexation Policy Plan to guide Eagle Mountain's future growth and turned time to Planning Director Brandon Larsen.

Eagle Mountain City Council Minutes – September 2, 2025 Page 2 of 10 Planning Director Brandon Larsen reviewed an Annexation Policy Plan map, focusing on water, power, transportation, and energy, and noted discussions with Fairfield Mayor Holly McKinney regarding future roads, the Rodeo Grounds, and annexation plans. Councilmembers and Staff discussed impacts on Cedar Fort, road connections, and long term transportation needs, with Mayor Pro Tempore Wright stressing the importance of flexibility for future freeway options.

City Attorney Marcus Draper explained that the City, DAI, and Browns Meadow reached an agreement to share the cost of a pressure releasing valve for the Browns Meadow Subdivision, with each party paying one-third of the total expense. Browns Meadow has already submitted payment for its portion. An agreement with DAI will return at a future meeting for its portion.

Planner Steven Lehmitz presented a rezone approval from Agriculture to Public Facilities, and Site Plan approval for a new elementary school to be located on Parcel No. 59:034:0186, directly north of the Pinnacles residential development.

The City Council expressed concern regarding student pickup and drop-off traffic circulation at the proposed school site. Mayor Pro Tempore Wright emphasized the importance of including adequate ingress and egress in the Site Plan to better address transportation and public safety needs. Councilmembers further discussed related safety concerns regarding fire and police access.

City Attorney Marcus Draper clarified that, while State Code does not require the School District to provide additional access, the City may use State Code provisions to encourage modifications that improve emergency response access.

17.A. RESOLUTION/PUBLIC HEARING - Resolution of Eagle Mountain City, Utah approving the Culinary Water Master Plan and Impact Fee Facilities Plan (IFFP)

City Engineer Vince Hogge presented the Culinary Master Plan and Impact Fee Facilities Plan for the City's culinary water utilities. The goal of this Master Plan is to stay ahead of the rapid growth the City is experiencing. The plan shows what the City's culinary water system will need to look like at full build-out and is intended to guide planning for growth in different areas.

18.A. ORDINANCE - An Ordinance of Eagle Mountain City, Utah Approving the First Amendment to Master Development Agreement for Ault Farms (Parkway Fields)

City Attorney Marcus Draper outlined an Amendment to the Master Development Agreement for Ault Farms (now the Parkway Fields subdivision) and stated that Flagship Homes requested the ability to bond for required privacy fencing due to supply delays. This would allow building permits to be issued while the fencing is installed. Councilmembers requested the language be revised to specify this as a temporary fix, ensuring it cannot be

used for long-term project purposes.

Planner Steven Lehmitz explained that this item is in relation to Item 16.A. Alpine School District is proposing the construction of an additional elementary school in Eagle Mountain, located on Parcel No. 59:034:0186, directly north of the Pinnacles residential

development.

Councilmember Wood expressed concerns regarding parking and safe ingress and egress at the school, emphasizing the need to work with the School District to find a compromise for improved outcomes in the future. Alpine School District Director of Facilities Frank Pulley and Alpine School District Representative Scott Johnson addressed the concerns and agreed to work with the City for future school sites, stating often they limited to properties that are available for purchase.

Councilmembers and the School District Representatives collaborated on ideas on how to help future schools in Eagle Mountain City.
