JOSE CALDERON - AFTER BEING SWORN IN SERGEANT ZAUGG READ THE DISPOSITION, ON APRIL 21ST, 2025, MR CALDERON'S UTAH CONCEALED FIREARM PERMIT WAS REVOKED BASED ON AN APRIL 16TH, 2025, ALCOHOL-RELATED CONVICTION INVOLVING DRIVING UNDER THE INFLUENCE, THROUGH THE STATE OF UTAH. ARMENTROUT'S UTAH CONCEALED FIREARM PERMIT WAS SUSPENDED BASED ON AN APRIL 22ND, 2024, ALCOHOL-RELATED CONVICTION INVOLVING DRIVER UNDER THE INFLUENCE, THROUGH THE STATE OF MONTANA.
