**Candidacy Filing: January 2, 2026 thru January 8, 2026, 8 am to 5 pm**, excluding weekends.

This filing deadline is for qualified political parties such as the Republican and Democratic parties as well as School Board.

**If you intend to gather signatures, you must declare so during Filing.** Signature packets must be submitted no later than 14 calendar days before your party's convention.

Non-partisan candidate filing extends to June 15<sup>th</sup>; certificates of nomination also due June 15<sup>th</sup>.  
Registered political party candidate filing extends to April 27<sup>th</sup> and signatures are due March 31<sup>st</sup>.  
Judges will file between July 1, 2026 and July 15, 2026.

In order to file as a candidate you must be a US Citizen, meet the legal requirements of that office, and be affiliated with the political party, if applicable.

To register to vote, you must be a US Citizen, a resident of Uintah County for at least 30 days before the election, and 18 years old on or before the day of the election.

**For the June Primary, June 23, 2026,** a voter's party affiliation CANNOT be changed after April 1, 2026. Those that are unaffiliated may still affiliate up through Election Day. There will be one vote center at the County Building at 147 East Main, Vernal from 7 am to 8 pm. Early Vote will be conducted in the Clerk-Auditor's office in the County Bldg., 8 am to 5 pm, June 9<sup>th</sup> thru June 19<sup>th</sup>, excluding holidays and weekends.

**The General will be held November 3, 2026.** There will be one vote center at the County Building at 147 E Main, Vernal from 7 am to 8 pm. Early Vote will be conducted in the Clerk-Auditor's office in the County Bldg., 8 am to 5 pm, October 20<sup>th</sup> thru October 30<sup>th</sup>, excluding holidays and weekends.

A military or overseas voter may use the electronic transmission system or any other approved method to apply for a military-overseas ballot by the Friday immediately before the election. (UCA 20A-16-401)

Voters with disabilities are encouraged to contact the Clerk-Auditor's office to determine the best method to assist them in voting, 435-781-5360. You can find information on the websites as well.
