Discussion of Fire Protection Agreements with the Municipalities

The cities can do as they please, but it would make enforcement easier if they were aligned with the county. The Commissioners would like the Cities' opinion. Nate Zilles with UBAOG explained that he has been in contact with all the municipalities and special service districts in the county for the updated CASOI requirements.
