CITY OF LOGAN, UTAH ORDINANCE NO. 25-21

AN ORDINANCE AMENDING SECTION 8.04.019 OF LOGAN MUNICIPAL CODE REGARDING WILDLAND – URBAN INTERFACE CODE

WHEREAS, the state legislature has granted general welfare power to the City Council, independent, apart from, and in addition to, its specific grants of legislative authority, which enables the City of Logan to pass ordinances as are necessary and proper to provide for the safety, promote the prosperity, improve the peace and good order, comfort, and convenience of the city and its inhabitants, and for the protection of property in the city;

WHEREAS, in the 2025 Utah General Session, the Utah state legislature passed House Bill 48 requiring municipalities to adopt the 2006 Utah Wildland-Urban Interface Code;

WHEREAS, the City of Logan wishes to adopt by reference the 2006 Utah Wildland-Urban Interface Code;

WHEREAS, the City of Logan wishes to adopt a Wildland-Urban Interface Map which delineates the wildland-urban areas within Logan City boundaries; and

WHEREAS, the City Council has determined that the following ordinance is in the City's best interest;

NOW THEREFORE, BE IT ORDAINED BY THE MUNICIPAL COUNCIL OF THE CITY OF LOGAN, UTAH, AS FOLLOWS:

SECTION 1:

8.04.019: 2006 UTAH WILDLAND-URBAN INTERFACE CODE AND LOGAN CITY WILDLAND-URBAN INTERFACE MAP ADOPTED:

- A. For the purpose of prescribing regulations governing conditions hazardous to life and property from impacts related to development in wildlands, the 2006 Utah Wildland Urban Interface Code, as adopted by Utah Code Section 15A-2-103, or its successor, is hereby adopted. A copy of the 2006 Utah Wildland Urban Interface Code shall be placed on file in the office of the Logan City Recorder for the use and examination of the public.
- B. The Logan City Wildland-Urban Interface Map, which delineates the wildland urban interface areas within Logan City, is hereby adopted. A copy of the Wildland-Urban Interface Map shall be placed on file in the office of the Logan City Recorder for public use and examination.

SECTION 2: Effective Date. This ordinance shall become effective upon publication.
