The Hinckley Deseret cemetery maintenance district tax on a 333,000 residence, for an example, will increase from 31.87 \$31.87 to \$44.13 which is \$12.26 per year. The Hinckley Deseret cemetery maintenance district tax on a three \$333,000

If the proposed budget is approved, Hinckley, Deseret cemetery and maintenance district would receive an initial \$10,000 in property tax revenue per year as a result of the tax increase. If the proposed budget is approved, Hinckley, Deseret cemetery maintenance district would increase its property tax budget revenue by 38.47%

above last year's property tax budgeted revenue, excluding eligibility new growth. The Hinckley Deseret cemetery maintenance district invites all concerned citizens to this public meeting for the purpose of hearing comments regarding the proposed tax increase and explain the reasons for the proposed tax increase.
