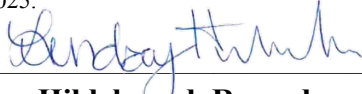

**2. PUBLIC COMMENTS**

**3. PUBLIC HEARING FOR THE 2025 AMENDMENT TO THE TRANSPORTATION IMPACT FEE FACILITIES PLAN & IMPACT FEE ANALYSIS**

**Council Member Harris made a motion to close the regularly scheduled City Council Meeting and open a public hearing for the 2025 amendment to the Transportation**

**Impact Fee Facilities Plan & Impact Fee Analysis. Council member Stoor seconded and all voted in favor.**

Tyler Melling, a resident and taxpayer of the city, spoke on behalf of Velocity Homes and also represented Ryan Talbot from the Iron County Home Builders Association, who was unable to attend due to travel. Tyler conveyed that Ryan reflected their shared sentiments, acknowledging the costs involved in such matters. He requested that if the council decided to modify the impact fee associated with each home, they would appreciate some time to discuss the changes within the industry. Tyler noted that typically, they are 30 to 90 days ahead when obtaining quotes for homes and applying for permits, indicating the need for time to adjust to any policy changes. He expressed appreciation to the council for their consideration.

**Council Member Harris made a motion to close the public hearing and reconvene the regularly scheduled City Council meeting. Council Member Ley seconded and all voted in favor.**

**4. CONSIDER ORDINANCE NO. 2025-11-19 AN ORDINANCE TO AMEND THE TRANSPORTATION IMPACT FEE FACILITIES PLAN & IMPACT FEE ANALYSIS**

Council Member Harris indicated that there would be no changes to the fee itself, but rather modifications to the projects and timelines. He explained that the fee had been originally set and discounted, and he believed the study was intended to modify it into phases. Ley mentioned that they needed to include this information in the report for acknowledgment. Stoor provided that the current impact fee stood at \$2,000 per Equivalent Residential Unit (ERU). There was a discussion regarding the potential use of a percentage formula to calculate the discount, with Council Member Ross suggesting that a flat rate would be more effective. It was proposed to eliminate the percentage calculation and maintain the current rate, allowing for potential increases later if necessary. The total maximum fee discussed was \$21,165.24, which would be discounted to \$2,000 for residential properties.

**Council Member Harris made a motion to approve Ordinance No. 2025-11-19 an ordinance to amend the Transportation Impact Fee Facilities Plan & Impact Fee Analysis and adopt the fee of \$21,165.24 and discount it to the current rate of \$2,000 per household. Mr. Nelson requested the annexation; his son wanted to build a home on a portion. The front two acres may be commercial at a later date.

**6. CONSIDER ORDINANCE NO. 2025-11-19-B AN ORDINANCE ANNEXING PROPERTY OWNED BY NELSON LIVING TRUST, PARCEL #D-0648-0001-0000, INTO THE CORPORATE BOUNDARIES OF ENOCH CITY**

Council Member Ley inquired whether all of the necessary infrastructure was in place. Hayden responded that the only missing component was the sewer, which is located across the street. He noted that septic systems are permitted in Enoch City, but that properties within 310 feet of the sewer must connect to it. This property will be on septic.
