NOTICE OF AMENDED TARIFF FILING

On January 7, 2015, the Commission issued an order suspending the proposed tariff filed by WaterPro Inc. (WaterPro) on December 19, 2014. That order is still in effect and also applies to the amended tariff filing referred to below.

On January 12, 2015, WaterPro filed an amended tariff filing. The amended filing proposes the following changes:

NOTICE OF RESCHEDULED HEARINGS
