2026 MEETING SCHEDULE**

A RESOLUTION OF THE LEEDS TOWN COUNCIL ESTABLISHING A TIME FOR REGULAR TOWN COUNCIL MEETINGS AND PLANNING COMMISSION MEETINGS

**WHEREAS**, the Town Council of the Town of Leeds has held a Town Council Meeting on the 10th day of December 2025; and discussed the 2026 meeting schedules; and

**WHEREAS**, the Town Council approved the 2026 meeting calendar with 2 Town Council meetings a month (second and fourth Wednesdays) for 8 months (January, February, March, April, May, June, September, and October) and 1 Town Council meeting a month (second Wednesday) for 4 months (July, August, November and December), and to approve 1 Planning Commission meeting a month (first Wednesday) for 11 months (February thru December) and 1 Planning Commission meeting on January on the first Tuesday of the Month; and

**WHEREAS**, the Town Council of the Town of Leeds understands the need to provide proper notice if any changes to this schedule become necessary.

**NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF LEEDS, UTAH, THAT THE FOLLOWING SHALL BE ADOPTED:**

**SECTION I  
SCHEDULE ADOPTION**

1. The Leeds Planning Commission will conduct Planning Commission Meetings at 7:00 PM in the Leeds Town Hall on the first Wednesday of the month for 11 months (February thru December) and on the first Tuesday in January. Meetings can be adjusted with proper notification and as allowed by law.
2. The Leeds Town Council will conduct Town Council Meetings at 7:00 PM in the Leeds Town Hall on the second and fourth Wednesday of each month for 8 months (January, February, March, April, May, June, September, October) and 1 Meeting a month (second Wednesday) for 4 months, (July, August, November and December). Meetings can be adjusted with proper notification and as allowed by law.
3. The Town Council will provide proper notice of any changes to this 2026 Town of Leeds Meeting Schedule.

**SECTION II  
SEVERABILITY**

If a court of competent jurisdiction declares any provision of this Resolution invalid, the remainder shall not be affected thereby.

**SECTION III  
EFFECTIVE DATE**

This Resolution sha

ll take effect immediately upon posting, as required by law, deposited and recorded in the office of the Leeds Recorder, and accepted as required herein.
