

## RESOLUTION NO. 23-2025

### **A RESOLUTION AMENDING AND PRESCRIBING NEW FEES FOR FIRE PREVENTION, FIRE AND EMS STANDBYS, PERMITS, SPECIALIZED SERVICES, COST RECOVERY, DOCUMENTS, AND OTHER FEES CHARGED TO AN INDIVIDUAL FOR SPECIFIC AND INDIVIDUALIZED SERVICES.**

WHEREAS, the Weber Fire District (the “District”) is a political subdivision of the state of Utah, authorized and organized under the provisions of Utah law;

WHEREAS, the District has legal authority, pursuant to Title 17B, Chapter 1, Section 643 of the Utah Code, Annotated, as amended (“Imposing or increasing a fee for service provided by local district”), to impose individual fees for a service provided by the District, which fees are used to defray costs attributable to administrative and operational services;

WHEREAS, historically the District has charged the same or similar fees included in the District’s Fee Schedule adopted March 10, 2020, and implemented April 11, 2020; and

WHEREAS, the District has amended and updated the District’s Fee Schedule as set out in Attachment “A” to more adequately meet the District’s current needs and interests in order to appropriately assign service costs to demand sources in an equitable and proportionate manner; and

WHEREAS, the District posted public notice of the District’s proposed new and increased fees, and public hearing pursuant to Utah Code Annotated Title 17B, Chapter 1, Section 643; and

WHEREAS, a legally noticed Public Hearing was held on this 9<sup>th</sup> day of December 2025, at 6:00 p.m. at the administrative offices of the Weber Fire District, 2023 West 1300 North, Farr West City, Utah, all in conformity with the requirements of Utah Code Annotated Title 17B, Chapter 1, Section 643. After holding a public hearing under Subsection (1), a local district may; (a) impose the new fee or increase the existing fee as proposed; (b) adjust the amount of the proposed new fee or the increase of the existing fee and then impose the new fee or increase the existing fee as adjusted.

NOW THEREFORE, the District Board of Trustees resolves as follows:

1. BE IT RESOLVED BY THE BOARD OF TRUSTEES OF THE WEBER FIRE DISTRICT THAT THE DISTRICT’S FEE SCHEDULE IS HEREBY AMENDED AS FOLLOWS:

That those changes set out in Attachment “A” dated as of the 9<sup>th</sup> day of December 2025, (to be attached hereto by staff, and incorporated herein as if fully set out,) ought to be, and the same are, hereby amended, re-adopted and enacted as amendments to the District Fee Schedule.

2. Effective Date. Adoption of this Fee Policy shall not repeal, modify or affect any fee of the District in existence as of the effective date of this Resolution. All fees established, including amendments and modifications to previously existing fees, after the effective date of this Resolution shall comply with the requirements of this Fee Schedule.

This Resolution shall be effective January 1, 2026.
