I, **Marla R. Young**, Box Elder County Clerk hereby give notice pursuant to Utah Election Code 20A-5-101 of the General Election to be held on Tuesday November 3, 2026.

- Notice is hereby given of the offices to be filled at the regular General Election along with the corresponding term, filing fee, and filing locations.
- Notice is given of the Declaration of Candidacy filing period for qualified political party candidates begins on Friday January 2, 2026 at 8:00 a.m. and ends at 5:00 p.m. Thursday January 8, 2026, and;
- The Declaration of Candidacy filing period for state and local school board candidates begins on Friday January 2, 2026 at 8:00 a.m. and ends at 5:00 p.m. Thursday January 8, 2026, and;
- The Declaration of Candidacy filing period for registered political party candidates begins on Friday January 2, 2026 at 8:00 a.m. and ends at 5:00 p.m. Monday April 27, 2026; and
- The Declaration of Candidacy filing period for justices and judges of a court of records begins Wednesday July 01, 2026 at 8:00 a.m. and ends at 5:00 p.m. Wednesday July 15, 2026, and;
- The Declaration of Intent to Gather Signatures period for qualified political party candidates begins on Thursday January 2, 2026 at 8:00 a.m. and ends at 5:00 p.m. Thursday January 8, 2026, and;
- The Declaration Period for candidates not affiliated with a political party begins on Friday January 2, 2026 at 8:00 a.m. and ends at 5:00 p.m. Monday June 15, 2026; and
- Candidates not affiliated with a political party must submit certificates of nomination no later than 5:00 p.m., Monday June 15, 2026.
- Candidates must submit nomination petition signatures no later than 14 days before the day on which the qualified political party holds its convention to select candidates for the elective office; and
- Registered political party candidates must submit nomination petition signatures no later than 5:00 p.m. Tuesday March 31, 2026.
