**1. Welcome.** Vice-Chair called the meeting to order. Public comment allowed, none was given. Mr. Bud Powell, Ex. Dir. of Utah Prosecutor Conduct Commission was present.

**2. Approval of Minutes.**

**3. Director's Report.** Mr. Peterson reviewed the Director's Report, updating the Commission on AJDC / CJE<sup>i</sup> (x7), JPEC<sup>ii</sup> (x0), CCJJ<sup>iii</sup> (x1), UCCD<sup>iv</sup> (x0), AOC<sup>v</sup> (x0), and GRAMA<sup>vi</sup>/Press (3) monthly requests. Staff reported on October Judicial Ethics Conference, travel claims, and likely future conferences. Mr. Powell was introduced and welcomed. Staff provided an update on website changes.

**4. Budget.** Staff reported on the FY25 budget through September 30, 2025 with total expenditures of \$159,464. Prior year savings and legislative additions to budget resulted in a carry forward balance of \$350,000. The JCC spent 17.1% of available funds through 16% of current FY. Staff reported Mr. McGivern hiring to full-time, impact on budget from travel and special hearing, and potential for a legislative budget cut.

In FY26, zero (0) Public Actions and two (2) Dismissal with Warnings has been issued. Thirteen (13) reconsideration requests received to date.

It has been acknowledged that the greater public access to complaint forms via the online complaint portal starting in FY22 has resulted in a significant increased complaint case load with no similar increase in meritorious complaints submitted. Staff implemented a loading page for the online complaint portal to emphasize the correct way to file appeals.
