Primary Uses:

Auxiliary Gym Bleachers and Floor Refinish

The auxiliary gym bleachers and gym floor serve a variety of important functions throughout the school year. Primarily, they provide seating for spectators and a space to play during basketball, volleyball, and wrestling events allowing students, families, and community members to support their teams in a comfortable and organized manner. In addition to athletic events, the bleachers and gym are commonly used during pep assemblies and other school gatherings, offering ample space for the student body and staff to come together for celebrations, announcements, and important presentations. The bleachers and gym floor also accommodate audiences for city recreation games, making the gym a hub for both school and community athletic activities. The bleachers and gym are an essential feature of the school and support a wide range of athletic and school-wide events.

Baseball and Softball Grandstand Bleacher

An aluminum bleacher grandstand behind the baseball backstop and behind the softball backstop would serve the school and patrons well. It would make available ADA seating and provide equal access for spectators. Currently there is not enough bleacher seating for the spectators so there is a mix of small bleachers seating, patrons bringing their own camp chairs, and patrons standing. An aluminum bleacher grandstand for baseball and softball would greatly improve the aesthetics of the facility and provide safe and ample seating for spectators.

Baseball Warning Track

The warning track on a baseball field is a strip of dirt approximately 15 feet wide that runs in between the grass and the outfield fence. The purpose of the warning track is to provide a safety alert to the outfielders as they chase fly balls. It is a texture change under foot and a visual cue that they are approaching the fence and helps the player avoid collision and injury.

Renovation of Baseball and Softball Restroom Facilities

The primary uses of the softball field restroom facilities at Gunnison Valley High are to serve athletes, students, staff, and community members during school sports events, physical education classes, and extracurricular activities. These restrooms provide essential sanitation and hygiene for participants and spectators during games, tournaments, practices, and community gatherings held at the school's outdoor fields. Additionally, they support after-school programs, summer camps, and

local recreational leagues that utilize the school's athletic facilities. By ensuring clean, accessible, and functional restrooms, the schools promote health, comfort, and inclusivity for everyone who uses the outdoor sports areas.

Wrestling Gym Bleachers

The wrestling gym bleachers provide seating for participants and spectators during wrestling events allowing students, families, and community members to support the wrestlers in a comfortable and organized manner. In addition to athletic events, the bleachers can be used during school for small group meetings, offering space for the students and staff to come together for celebrations, announcements, and important presentations. The bleachers in the wrestling gym also accommodate audiences for city recreation wrestling, making the gym a hub for both school and community athletic activities. The bleachers in the gym are an essential feature of the school and support a wide range of athletic and school-wide events.

Project Narrative:

Auxiliary Gym Bleachers and Floor Refinish

The current wooden bleachers and gym floor in the auxiliary gym are original to the building, having served the school and community since the 1960's. Over time, the bleacher tracks have become worn and difficult to operate, requiring the effort of at least three staff members and 10 of the biggest boys in the school to manually pull them out and retract them for events. This not only poses safety risks but also limits accessibility for individuals with disabilities, as the existing bleachers do not meet ADA compliance standards. Replacing these outdated, labor-intensive bleachers with new, ADA-compliant electric track bleachers will greatly improve safety, efficiency, and inclusivity. The new system will allow for effortless, one-person operation at the push of a button, and will provide accessible seating options for all members of the community. The refinish of the gym floor will help freshen up the gym. The gym floor needs to be sanded down to the original wood and then refinished with new lines and logo painted. These upgrades ensure the gym remains a welcoming and functional space for athletic events, assemblies, and community activities for years to come.

Baseball and Softball Grandstand Bleachers

The purpose of this project is to purchase and install an aluminium grandstand bleacher at Gunnison Valley High's Baseball and Softball fields to accommodate the growing number of spectators attending school athletic events. Over the past several years, our school has seen increased student participation in sports and greater

community engagement. Unfortunately, our current seating is insufficient, often leaving many attendees without a place to sit, which can diminish the experience for students, families, and community members.

By investing in a grandstand for each field, we aim to provide safe, comfortable, and accessible seating for all spectators. The new bleachers will be designed to meet ADA requirements, ensuring that individuals with disabilities have equal access to events. This project will enhance school spirit, improve safety, and foster a sense of inclusion for everyone who attends our games and activities. Ultimately, expanding our seating capacity will support our school's mission to build a welcoming and supportive environment for students and the broader community.

Baseball Warning Track

This project will remove an approximately 15 foot strip of grass along the outfield fence to install a warning track made of dirt. The process begins with removing grass, followed by grading the area to ensure a smooth, even surface with a specialized dirt. The dirt will then be laid to create a warning track that gives players a clear tactile and visual cue as they approach the fence, improving safety and field functionality. Adequate drainage will be designed and installed to prevent water accumulation on the dirt surface next to the fence, preserving the quality and safety of the track. Sprinklers within the new warning track area will be relocated to avoid watering the dirt and to maintain healthy turf elsewhere on the field. Importantly, this warning track installation addresses a risk management item that has been requested in the past, further supporting efforts to reduce injury risks and align the field with current safety standards.

Renovation of Baseball and Softball Restroom Facilities

The project involves a remodel of the outdated and dilapidated baseball and softball field restrooms at Gunnison Valley High. The initial phase consists of gutting the existing facilities, removing all old fixtures, partitions, plumbing, and electrical systems to address long-standing issues of wear, safety, freezing, and code compliance. Once cleared, the restrooms will be remodeled with a strong emphasis on accessibility, hygiene, and durability.

ADA-compliant features will be incorporated throughout, including doorways, accessible stalls, and sinks positioned at appropriate heights to ensure all users, regardless of ability, have safe and convenient access. To promote cleanliness and reduce the spread of germs, the restrooms will feature no-touch flush toilets and urinals, as well as sensor-activated sinks and soap dispensers. Energy-efficient LED lighting will be installed to provide bright, reliable illumination while lowering utility costs and maintenance needs.

The entire space will be refreshed with easy-to-clean, vandal-resistant surfaces, improved ventilation, and enhanced privacy for users. This comprehensive renovation will result in modern, inviting restroom facilities that meet current codes and community expectations, supporting the comfort, safety, and dignity of all students, athletes, staff, and visitors during school and community events.

Wrestling Gym Bleachers

The manual 3 row bleachers in the wrestling gym are original to that section of the building built in the early 1980's. Over time, the bleacher tracks have become worn and difficult to operate, requiring the effort of at least three staff members to pull them out and retract them for events. This not only poses safety risks but also limits accessibility for individuals with disabilities, as the existing bleachers do not meet ADA compliance standards. Replacing these outdated, labor-intensive bleachers with new, ADA-compliant electric track bleachers that have 6 rows of seating will greatly improve capacity, safety, efficiency, and inclusivity. The new system will allow for effortless, one-person operation at the push of a button, and will provide accessible seating options for all members of the community. The bleacher upgrade ensures the gym remains a welcoming and functional space for athletic events, gatherings, and community activities for years to come.


