Proposed Expansion of Athletic Facilities at Green River High School

Current Athletic Facilities and Student Opportunities

Green River High School (GRHS) is a small, rural school serving a diverse student body with a strong tradition of athletic participation and community pride. Our current athletic facilities support programs in basketball, volleyball, track and field, baseball, and cross country. Despite the dedication of our student-athletes and coaches, our facilities remain limited in scope, restricting the breadth of programs and opportunities available to our students.

Currently, students participate in physical education classes and extracurricular programs using shared or multi-purpose spaces. While these areas serve us well, they do not adequately support the development of lifelong fitness habits or the skill-specific instruction needed to align with Utah's physical education core standards. Expanding our athletic facilities—specifically by adding new tennis/pickleball courts—would create access for more inclusive physical education, health, and wellness opportunities.

Educational Integration: Curriculum and Beyond

The proposed courts would serve as an essential instructional space within our physical education curriculum. These courts would:

- **Support Standards-Based Instruction:** Allow educators to deliver state-aligned curriculum focusing on skill development, teamwork, sportsmanship, and lifelong wellness.
- **Expand Learning Opportunities:** Provide facilities for diverse sports such as pickleball, tennis, and outdoor fitness training—activities that promote individual goal-setting and student choice.
- **Enhance Cross-Curricular Learning:** Offer real-world applications for math (data tracking and measurement), science (movement and energy), and health education (fitness tracking, heart rate monitoring, etc.).

Beyond daily instruction, these courts would be a **hub for extracurricular engagement**—hosting after-school programs, team practices, community leagues, and inter-school competitions. They would also serve as a **safe, positive environment** for students to gather, strengthening school culture and community connection.

Community Impact and Long-Term Vision

In a rural community like Green River, our school is often the heart of local activity. The addition of multi-use courts would not only benefit students but also provide access for families and community members to engage in health and wellness activities. GRHS envisions these facilities as shared community assets—used for family recreation nights, intramural events, and regional tournaments—strengthening partnerships between the school, city, and local organizations.

Investing in this project aligns directly with our **School Improvement Plan** goals, which emphasize academic growth through engagement, wellness, and connection. Research shows that students who are physically active demonstrate improved concentration, attendance, and academic performance. This project is more than a facilities upgrade—it's an investment in the holistic development of every GRHS student.

Conclusion

With the support of this funding, Green River High School will be able to expand educational and extracurricular opportunities, foster wellness and community engagement, and inspire students to lead active, healthy lives. 



5 - PICKLEBALL COURTS


SITE PLAN
