

1 **R277. Education, Administration.**

2 **R277-609. Standards for LEA Discipline Policy.**

3 **R277-609-1. Authority, Purpose, and Oversight Category.**

4 (1) This rule is authorized by:

5 (a) Utah Constitution Article X, Section 3, which vests general control and
6 supervision over public education in the Board;

7 (b) Subsection 53E-3-401(4), which allows the Board to make rules to execute
8 the Board's duties and responsibilities under the Utah Constitution and state law;

9 (c) Subsection 53E-3-501(1)(b)(v), which requires the Board to establish rules
10 concerning discipline and control;

11 (d) Section 53E-3-509, which requires the Board to adopt rules that require a
12 local school board or governing board of a charter school to enact gang prevention and
13 intervention policies for all schools within the board's jurisdiction;

14 (e) Section 53G-8-702, which requires the Board to adopt rules regarding
15 training programs for school principals; and

16 (f) Section 53G-8-202, which directs local school boards and charter school
17 governing boards to adopt conduct and discipline policies and directs the Board to
18 develop model policies to assist local school boards and charter school governing
19 boards.

20 (2) The purpose of this rule is to outline requirements for an LEA's discipline
21 policy and related plans.

22 (3) This Rule R277-609 is categorized as Category 2 as described in Rule R277-
23 111.

25 **R277-609-2. Definitions.**

26 (1)(a) "Accountability Practice" means any evidence-based practice that
27 increases academic outcomes, decreases behavior that disrupts the learning
28 environment and holds students accountable for their actions by requiring them to take
29 responsibility to repair harm and provide restitution when appropriate.

30 (b) [Some p]Practices may include[adapting instruction to increase
31 engagement,] behavior plans, [and-]restorative practices, and strategies to increase
32 engagement.

39 (3) "Discipline" means school discipline and refers to the rules and evidence-
40 based strategies applied in school to manage student behavior.

41 (4) Discipline policy means one or more LEA policies that includes the provisions
42 required by this Rule R277-609.

43 (5) "Electronic cigarette product" has the same meaning as that term is defined
44 in Section 76-10-101.

45 (6) "Emergency safety intervention" or "ESI" means the same as described in
46 Section R277-608-2.

47 (7) "Evidence-based" means the same as defined in Section 53G-8-211.

48 (8) "Expulsion" means a disciplinary removal from school for more than ten
49 school days without an offer of alternative education service.

56 (10) "Incident" means the same as defined in Rule R277-613.

57 (11) "Infraction" means the same as defined in Rule R277-613.

58 (12) "LEA" includes, for purposes of this rule, the Utah Schools for the Deaf and
59 the Blind.

60 (13) "LEA Plan" means a data-driven written process or procedure that outlines
61 the implementation of strategies that positively impact student behavior throughout the
62 LEA.

63 (14) "Positive behavior interventions and support" means an implementation
64 framework for maximizing the selection and use of evidence-based prevention practices
65 along a multi-tiered continuum that supports the academic, social, emotional, and
66 behavioral competence of a student.

67 (15) "Program" means an instructional or behavioral program including:

68 (a) contracted services offered by private providers under the direct supervision
69 of public school staff;

70 (b) a program that receives public funding; or

71 (c) a program for which the Board has regulatory authority.

72 (16) "Prohibited student behavior" for the purposes of this rule includes:

73 (a) the grounds for suspension or expulsion described in Section 53G-8-205
74 including disruption; and

75 (b) the conduct described in Subsection 53G-8-209(2)(b).

76 (17) "Qualifying minor" means a

77 (a) is at least nine years old; or

78 (b) turns nine

(18) "Restorative justice program" means the same as that term is defined in Section 53G-8-211.

(19) "Restorative practice" means to help minors take responsibility for and repair harmful behavior that occurs within the school community.

83 (20) "School employee" means:

84 (a) a school teacher;

85 (b) a school staff member;

86 (c) a school administrator; or

87 (d) any other person employed, directly or indirectly, by an LEA.

(21) "Suspension" means the same as defined in Section R277-100-2 and as described in Section 53G-8-206.

91 R277-609-3. Actions Required to Create or Update an LEA Discipline Policy.

92 (1) An LEA or school shall develop and implement a board-approved LEA policy
93 for school discipline.

94 (2) An LEA shall include administration, instruction and support staff, students,
95 parents, community council, and other community members in policy development,
96 training, and prevention implementation to create a community sense of participation,
97 ownership, support, and responsibility.

102 (4) An LEA may incorporate Rule R277-609 into one or more of its LEA policies,
103 ensuring that all disciplinary practices are consistent with the requirements established
104 in this rule.

105 (5) An LEA shall develop uniform and equitable methods for a school level data-
106 based evaluation of the efficiency and effectiveness of the policy on an annual basis.

107 (6) An LEA shall publish a notice to parents and school employees of the
108 discipline policy by reasonable means.

110 R277-609-4. School Conduct and Discipline Policy.

111 (1) An LEA discipline policy shall include:

112 (a) provisions consistent with:

113 (i) the requirements of Section 53G-8-210;

114 (ii) the requirements of Subsection 53E-7-207(5);

115 (iii) the requirements of Rule R277-750, including:

(A) procedural safeguards;

(B) child find;

(C) IEP development, review, and revision; and

(D) discipline procedures requirements; and

(iv) the child find provisions in Section 504 of the Rehabilitation Act of 1973.

(b) grounds for suspension and expulsion consistent with Section 53G-8-205;

(c) alternatives to suspension and expulsion consistent with Section 53G-8-207;

(d) direction for schools to determine the range of prohibited behaviors and establish the continuum of administrative procedures that may be used by school personnel to address prohibited student behavior;

(e) parent responsibilities as described in Section 53G-8-208.

(f) federal legal requirements, including IDEA, Title IX, and the Americans with Disabilities Act;

(g) identification, by position, of an individual designated to issue notices of prohibited student behavior as described in Section 53G-8-210;

(h) identification of individuals who shall receive notices of prohibited student behavior as described in Section 53G-8-210;

(i) the parent notification requirements in Section 53G-8-210; and

(j) provide procedures for qualifying minors and their parents to participate in decisions regarding consequences for prohibited student behavior.

(k) provide due process procedures for minors and parents to contest allegations and citations of prohibited student behavior.

(2) An LEA discipline policy, shall include provisions that apply to the following specific incident and infractions types:

(a) the illicit use, possession, or distribution of:

(i) alcohol;

(ii) tobacco and nicotine products, including electronic cigarettes, as defined in Section 76-10-101; and

(iii) marijuana and controlled substances as defined in Section 58-37-2;

145 (b) specific conduct as described in Subsection 53G-8-209(2);
146 (c) provisions and procedures, consistent with requirements of Rule R277-613;
147 (d) gang prevention and intervention provisions in accordance with Subsection
148 53E-3-509(1);
149 (e) responses to defacement of school property consistent with Sections:
150 (i) 53G-8-212;
151 (ii) 76-6-101; and
152 (iii) 80-6-610.
153 (f) responses to attendance concerns as described in Rule R277-607; and
154 (g) serious offenses of sexual crimes as described in Sections:
155 (i) 53G-8-201;
156 (ii) 53G-8-203; and
157 (iii) 53G-8-213.
158 (3) An LEA discipline policy shall also include direction on the following available
159 supportive or emergency responses:
160 (a) strategies that align with the LRBI manual incorporated in this rule;
161 (b) the appropriate use of accountability practices;
162 (c) the use of emergency safety interventions as outlined in Section R277-608-3
163 for all students consistent with evidence-based practices and Rule R277-608;
164 (d) the use of SafeUT as described in Section 53G-8-203;
165 (e) threat assessment as described in Rule R277-400; and
166 (f) additional provisions that account for an individual LEA's or school's unique
167 needs or circumstances, including:
168 (i) the role of law enforcement; and
169 (ii) emergency medical services.

171 **R277-609-5. LEA Responsibility to Implement Positive Behavior Interventions,
172 Supports and Accountability Practices.**

173 (1) An LEA shall implement positive behavior interventions, supports, and
174 accountability practices as part of the LEA's continuum of behavior interventions
175 strategies.

176 (2) LEA plans shall use:

177 (i) written standards for student behavior expectations, including schoolwide and
178 classroom management;

179 (ii) effective instructional practices for teaching student expectations;

180 (iii) systematic methods for reinforcing expected behaviors;

181 (iv) uniform and equitable methods for correcting student behavior; and

182 (v) procedures for re-teaching behavior expectations followed by effective,
183 evidence-based interventions matched to student needs before suspension or cou
184 referral;

185 (vi) procedures for referral for a student with a qualifying offense to alternative
186 school-related interventions as described in Section 53G-8-211.

187 (3) An LEA shall provide an ongoing staff development program as described in
188 Rule R277-608.

190 R277-609-6. LEA Reporting.

191 (1) An LEA shall develop a consistent process to collect incident, infraction, and
192 discipline data, including the number of days of student suspensions and expulsions.

193 (2)(a) An LEA shall submit all required incident, infraction, and discipline data,
194 including suspensions and expulsions consistent with Rule R277-484;

195 (b) An LEA shall submit any yearly and comprehensive updates no later than
196 June 30th of each year.
