1. BUSINESS ITEMS

Board meeting began at 5:00 p.m.

In attendance were: Board President Rich Brotherson, Vice President Jeremy Madsen, board members Greg Bailey, Stacey Goble and Joseph Cook. Others in attendance were Superintendent O'Dee Hansen, Assistant Superintendent Rena Orton, Business Administrator Tammy Jorgensen, Accountant Bryce Warby, Secretary Melanie Lee, Principal Christy Straatman, Julie and Cory Reese.

 Assistant Superintendent Orton offered the prayer.
- B. Pledge of AllegianceMr. Brotherson led the pledge.
- C. Board Recognition and Board ReportsMr. Madsen celebrated the orchestra we will hear tonight.

Mr. Bailey recognized Principal Ericksen for his many years of dedicated teaching and leadership. He will be greatly missed.

Mrs. Goble celebrated the special education department for the impactful work they do and the meaningful opportunities they provide for students to learn and participate in activities.

Mr. Cook recognized the middle school principal, sharing how he quickly addressed a concern from a grandmother who was worried about her grandchild. He expressed how happy he is



for Principal Ericksen and the direction he's headed, and how much he will be missed. He closed by expressing his gratitude for strong, caring principals.

Principal Straatman celebrated Principal Ericksen and shared that she was able to take part in honoring him as the State Secondary Principal of the Year. It was a great representation of our district.

She also expressed how grateful she is for the community. During the kickoff assembly fundraiser, the school directed support to a family with a child battling cancer. Even in a community with many needs, they continue to give back.

She mentioned giving out Quarters for Christmas gift cards to a few students who were very grateful.

Business Administrator Mrs. Jorgensen said it was incredibly hard to keep Principal Ericksen's secret, but it's a wonderful opportunity for him. She highlighted the Super Star celebrations, noting that this month's honorees are two classified employees—a bus driver, Linda Wright, and a food service manager, Melanie Smith. Tammy is excited that she gets to fill in for Melanie's half-day schedule. She emphasized the positive impact this program is having on employees, giving them a well-deserved break while allowing us to step into their roles, gain a better understanding of their responsibilities, and appreciate the work they do even more.

Assistant Superintendent Orton Recognized the Sight Buddies program—76 students received glasses—with support from the Moroni Strong ladies and the school nurse who assisted in obtaining parent permissions.

Superintendent Hansen celebrated receiving the \$500,000 sports facility grant. Out of 24 projects submitted, 10 were awarded funding. While we didn't receive the small school district grants, our applications ranked among the top, and we will continue applying.

Mr. Brotherson recognized a former teacher, Harold Mickel, who passed away.
