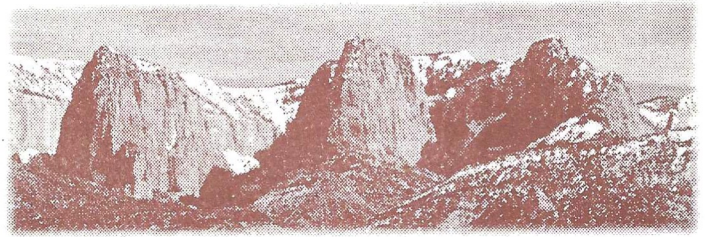

Those in attendance: Larsen, Pace, Allan, and ~~Larsen~~ Batty. Mayor Prince excused.

## Call to Order

1. Minutes from October meeting read by clerk. Motion to accept made by Allan, 2<sup>nd</sup> by Pace. Unanimous vote.
2. Diana Stiller- follow up on the grant money. Also want to have town consider marketing the town.
3. Apple Fest – Larsen ask to have it tabled until next month. Allan made motion 2<sup>nd</sup> by Batty. Unanimous vote.
4. Christmas Activities – Founders Day will be December 13, 2025. Looking for other items to decorate the town park, post office, and the bridge. Do they have permission to decorate the post office. Would also like an additional \$500 for the decorations. Motion to give committee the extra \$500 made by Allan, 2<sup>nd</sup> by Pace Unanimous vote. Wreaths Across America. Still need more donations to get wreaths.
5. Ordinance violations - Ronette Millard presented her side of the issue of having too many animals.  
Ms, Millard wants clarification of what the town wants. Also to know how many mini horses the council will allow to remain on her property. Felt that things had been misrepresented to her by town authorities. Attorney for town (Spencer) explained what she can do. She asked for 3 months to have time to dispose of her medium animals (mini horses). Motion to allow her 45 days from date of this meeting to dispose of her medium size animals, with her reporting back to council during the December 3, 2025 of her progress made by Batty, 2<sup>nd</sup> by Allan, Unanimous vote.

Jana Gardner – representing her father Dave Gardner as to having an RV being used for a living area for her brother Jason to stay in. Requested that the council allow it to stay the same. Would like to ask council to allow “Reasonable Accommodations” according to the ADA. Attorney restated the ordinance and that what they are doing is not in compliance. Motion to allow the family 30 days or until the next meeting in December 3, 2025 to come up with a solution made by Batty, 2<sup>nd</sup> by Pace. Unanimous vote. Larsen said he wants to have a solid plan of what they will do.

6. Reports – Pace the cemetery had a lot of damage and has been repairing graves. Batty – we are back on the spring and testing is going forward. Work is going forward on the fence for water tank. Allan – trimming of the park is going forward. Talked to company about putting pavilion over the cement. Larsen – Dana Dahl’s culvert needs to have the area around it and the area downstream cleared. He has permission to do so by property owners. Fire Chief said Ms. Dahl has been talking to him about the damage during the flood.

7. Motion to adjourn made by Pace, 2<sup>nd</sup> by Batty, unanimous vote.
