MINUTES:

Motion by Dave Larsen that minutes of the regular meeting of the Wales Town Council held on October 7th, 2025 be accepted as written; Council member Roberts seconded the motion.

INVOICES:

A list of invoices for the month of October 2025 was distributed and reviewed. Council member Roberts made a motion to approve payment of the invoices; Council member Larsen seconded the motion.

1. Kevin Daniels, Wales Town's lawyer, gave a report by phone on changes to the election because of the disqualification of all candidates due to lack of proper financial declarations being submitted. Tentatively based on present information researched by Mr Daniels, resignations, applications and appointments to these positions will happen in coming meetings.

2. Lynn Wall of Wall Engineering presented the present status of the “Line Loop/Booster Pump” project. He also presented the Town with maps and binders giving locations of all the water infrastructure presently in place.

BUSINESS & PETITIONS:

3. Kevin Dibb of Express Billpay gave an audio/visual presentation enabling residents to make water bill payments conveniently on line. One time costs of approx. \$1,600 for setup and monthly cost of \$129 with expected increase of 65% to 90% in collections. Residents have the option to continue with the existing method of payments. It was moved by Councilman Roberts that we get started on this change to Express Billpay and accept it. Second by Councilman Larsen.

4. Discussion was had regarding changing from our present Credit Union, Utah Heritage to Mountain America Credit Union to take advantage of increased interest on our checking and savings accounts at the recommendation of Gary Keddington the towns accountant. It was decided to get more information before moving on this change.

Council member Roberts made the motion to adjourn, seconded by Council member Larsen


