2. Congestion Mitigation Air Quality (CMAQ) Timeline

Tyler Laing from UDOT reported that two CMAQ projects were submitted in 2024. December 15, 2025 is the deadline for Letters of Intent for the next CMAQ cycle. More applications are needed and welcome. WFRC and UDOT will reach out to Tooele Valley communities about potential CMAQ eligible projects. It is anticipated that about \$1.0M of CMAQ funds will be available.

3. SR-36/ I-80 Projects Update

Sarah Kaye from the project team reviewed the schedule for widening of SR-36 to 3 lanes in each direction from Stansbury Parkway to I-80. Daily lane closures will occur so please plan ahead. She reviewed two new intersection cross sections with dual left turn lanes and dual right turn lanes. For the I-80 EB portion of the project, there will be an auxiliary lane constructed.

4. Connectivity Study Analysis Outcomes and Recommendations

Travis Hair explained that the Connectivity Study was developed to help communities and partners prepare for the continued rapid growth coming to Tooele County. This study was started earlier this year and the final recommendations should be completed by December 2025. The study addresses how east/west routes can distribute traffic more effectively. By 2050, population is expected to double (reaching 140,000), and

employment will triple (reaching 65,000). Inland Port expansion will also have significant traffic impacts.

Kai Tohinaka with the consultant team reviewed travel modeling conducted in the study.

Connectivity recommendations include:

- 33rd Parkway extended west
- 2000 N extended west
- 2400 N extended west
- Additional east/west connects
- Access management on all routes

The Connectivity Study is a guiding document as a starting point for further discussion. UDOT urged that development in coming years not leave neighborhoods in an isolated "cul-de-sac" configuration, but to keep connections open from multiple directions.

Next steps will include completion of the Connectivity Study report, potential inclusion of recommendations in the Long Range Plan, designing access management for SR-112 and SR-138, and potential inclusion of recommendations in local master plans.
