1. CALL TO ORDER

2. ELECTION RESULTS

a. 2025 General Election Results

City Recorder Tangee Sloan reviewed the 2025 General Election results including ballot counts and provisional ballot totals provided by Salt Lake County. She noted that several precincts did not report results because some have no population while others had no participation.

She read the voting totals for six candidates on the general election ballot as follows:

Sergio Sotelo	5,516	16.41%
Chris McConnehey	5,344	15.90%

Voting statistics were reviewed. Voter Turnout was 24.4%, with 55,337 active voters and 13,492 ballots counted. A total of 17 provisional ballots were issued, and 16 were counted, reflecting 94.1%. By Mail ballot data showed 123 challenged curable ballots: 77 with non-matching signatures, six unsigned, and three challenged for other reasons. Additionally, 93 ballots were returned after the deadline and eight were rejected for other non-curable reasons. Overall, two percent of ballots were returned as undeliverable.

Ms. Sloan also displayed a voting precinct map highlighting precincts that did not report results. She noted that many of these precincts have no residents, while others do have people living there who simply did not vote.
