#### 3. Instructional Model:

The school employs innovative learning strategies including Explicit Learning Techniques, Project-Based Learning, and other evidence-based instructional methods to foster deep understanding and real-world application.

#### 4. Mentoring and Character Development:

Merit offers a unique, schoolwide mentoring program that supports students' academic growth, leadership, and life skills from grades 7–12, with yearly themes such as belonging, vision, determination, and service.

### 5. Service and Citizenship:

Merit emphasizes service as a core value, requiring students to complete biannual service logs and participate in an annual schoolwide legacy event to promote meaningful community engagement.

#### Rationale and Educational Justification

Merit Preparatory Academy seeks approval to amend its charter to allow for online and blended educational delivery models that align with the school's mission: to provide an outstanding educational experience designed to instill excellence, build a love of learning and service, and create principled leaders who engage in real-world challenges and opportunities.

This amendment does not represent a change in mission or educational philosophy. Rather, it is a natural extension of Merit's existing program, enabling the school to serve students more effectively and sustainably. The ability to provide high-quality online learning options will strengthen academic offerings, address physical space constraints, and extend the reach of Merit's mission to students throughout the state.

#### **Ensuring Quality and Compliance**

Merit is fully committed to meeting and exceeding all Utah State Board of Education standards for online learning. The school has consulted with the Statewide Online Education Program (SOEP) and will continue to collaborate closely to ensure compliance with state expectations and best practices.

All online courses will:

- Align fully with Utah Core Standards.
- Be delivered through Canvas, Merit's official Learning Management System (LMS).
- Provide active and frequent teacher contact, exceeding state minimum requirements to ensure strong virtual support and engagement.

- Maintain measurable standards of active participation for every student.
- Utilize licensed, highly qualified Utah educators who have completed ethics training and background checks.
- Maintain a minimum 80% course completion rate to ensure program success and integrity.

Merit will also continue to serve all student populations—including students with disabilities, multilingual learners, and those needing accommodations—consistent with IDEA, Section 504, and Title III requirements.

## **Instructional Model and Pedagogy**

Students enrolled in Merit's online courses will continue to experience the distinctive features of a Merit education. Instruction will remain grounded in Project-Based Learning, peer-to-peer dialogue, experiential learning, and service learning—all central components of our current in-person program. These methods will be thoughtfully adapted for virtual delivery to ensure that students remain active participants in their learning and connected to our community.
