RESOLUTION SETTING REGULAR MEETING SCHEDULE - TOWN COUNCIL - 2026

WHEREAS, Pursuant to Utah State Code § 52-4-202(2) a public body shall fix the time and place of its regular meetings.

WHEREAS, the Virgin Town Council has previously established its work meetings for the second Wednesday of each month beginning at 6:00 p.m.

WHEREAS, the Virgin Town Council has previously established its regularly scheduled meetings for the third Tuesday of each month beginning at 6:00 p.m.

NOW, THEREFORE, BE IT RESOLVED by the Virgin Town Council as follows:

1. That this Town Council will hold its work meetings on the second Wednesday of every month. Work meetings in April, and July will be held on the Third Wednesday of each month with November being held on Thursday, with no work meeting held in December. Work meetings will begin at 6:00 p.m. in the Old Church at Heritage Town Square located at 114 S Mill Street in Virgin, Utah, and shall continue at this location until the new Town Hall at 40 W. Main Street is officially opened.
2. That this Town Council will hold its regular meetings on the third Tuesday of every month. Regular meeting will begin at 6:00 p.m. in the Old Church at Heritage Town Square located at 114 S Mill Street in Virgin, Utah, and shall continue at this location until the new Town Hall at 40 W. Main Street is officially opened.
3. That pursuant to Utah State Code § 52-4-202(3) the Virgin Town Clerk shall cause a copy of this resolution to be posted at the Virgin Town Hall, on the Utah Public Notice Website, on Virgin Town's website.
4. Effective Date. This resolution shall take effect immediately upon passage and adoption.
