DISCOVERY

Discovery turnaround times shall be 14 calendar days until April 10, 2026, and 7 calendar days thereafter. Parties shall serve discovery requests and responses on parties by email. If a document produced in response to a discovery request cannot reasonably be transmitted by email, the party disclosing the document shall provide an electronic copy of the document on CD (or, if an electronic copy is not available, a paper copy).

NOTICE OF HEARING

The PSC will conduct a hearing in this docket on **Wednesday, June 24, 2026, beginning at 9:00 a.m.** The hearing will be held in the **Fourth Floor Hearing Room 403, Heber M.
