ORDINANCE NO. 25-61

**AN ORDINANCE ADOPTING THE 2026 ANNUAL MEETING SCHEDULE
FOR MEETINGS OF THE WEST JORDAN CITY COUNCIL**

WHEREAS, per Utah Code Annotated 10-3-502 (1), the City Council shall by ordinance prescribe the time and place for holding its regular meeting and the Council shall hold a regular meeting at least once each month; and

WHEREAS, per Utah Code Annotated 52-4-202, the Utah State Legislature has further required public bodies which hold regular meetings scheduled in advance over the course of a year to give public notice of the annual meeting schedule, and to include the date, time, and place of such meetings; and

WHEREAS, the City Council has deemed it appropriate to establish an annual meeting schedule for the year 2026 for meetings of the City Council.

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF WEST JORDAN, UTAH AS FOLLOWS:

Section 1. The City Council hereby adopts the 2026 Annual Meeting Schedule as attached for the City Council.

Meetings of the City Council: are generally held on the second and fourth Tuesdays of each month. The meeting will begin with a Committee of the Whole work session at 4:00 pm, followed by the Regular City Council meeting at 7:00 pm. In months with five Tuesdays, an additional Committee of the Whole work session will be held at 6:00 pm on the fifth Tuesday. Special meetings may be convened at alternate times and locations as designated by the City Council, with appropriate public notice. Meetings may also be canceled due to unforeseen conflicts or if there are no agenda items.

Location of Meetings: The time, date, and location of each meeting are noted at the top of each agenda. All meetings take place at City Hall, 8000 South Redwood Road, 3rd floor, West Jordan, UT 84088. Meetings may be held at other locations as designated by the City Council.

Section 2. The City Recorder or designee is authorized to publish a copy of the attached Annual Meeting Schedules 1) at the principal office of the public body; 2) on the Utah Public Notice website; and 3) on the West Jordan City website.

Section 3. Effective Date: This Ordinance shall become effective immediately upon posting or publication as provided by law and upon (i) the Mayor signing the Ordinance, (ii) the City Council duly overriding the veto of the Mayor as provided by law, or (iii) the Mayor failing to sign or veto the Ordinance within fifteen (15) days after the City Council presents the Ordinance to the Mayor.

Council meetings are generally held on the second and fourth Tuesdays of each month. The meeting will begin with a Committee of the Whole work session at 4:00 pm, followed by the Regular City Council meeting at 7:00 pm. In months with five Tuesdays, an additional Committee of the Whole work session will be held at 6:00 pm on the fifth Tuesday. All meetings take place at City Hall, 8000 South Redwood Road, 3rd floor, West Jordan, UT 84088.

Special meetings may be convened at alternate times and locations designated by the City Council, with appropriate notice. Meetings may also be canceled due to unforeseen conflicts or lack of agenda items.

These meetings are open to the public, unless closed in accordance with Utah's Open and Public Meetings Act.
