

ORDINANCE 2025-24

AN ORDINANCE ENACTING TITLE 8-9: INTERFERENCE WITH CITY OPERATIONS

WHEREAS: North Ogden City has many responsibilities and obligations for services which occur on a regular basis; and

WHEREAS: the City has tasked various employees with the responsibility for various duties; and

WHEREAS: the City occasionally must perform work which is urgent in nature; and

WHEREAS: the interference with these official tasks is inherently dangerous, problematic, and leads to additional delays, costs, and risk of injuries to employees and residents.

NOW THEREFORE, BE IT ORDAINED by the Mayor and Council of North Ogden City hereby adopt:

SECTION 1: The following code section shall be enacted in Title 8 of the North Ogden Code

8-9: INTERFERENCE WITH CITY OPERATIONS

8-9-1: INTERFERENCE PROHIBITED:

- A.** It is unlawful for any person to use force, violence, intimidation, or to engage in any other unlawful act, with the purpose to interfere with a governmental employee engaged in the official business.
- B.** It is unlawful for any person to intentionally or knowingly adjust, change, or take control of any city equipment, fixtures, buildings, utilities, or other city-owned facilities.
- C.** It is unlawful for any person to block or otherwise interfere with governmental employees, vehicles, and equipment which is performing official duties.
- D.** It is unlawful for any individual to remain within a city work site, emergency work location, without property safety attire, or after being asked to remain a safe distance away from the work/emergency work/project area.
- E.** Nothing shall be interpreted in this ordinance to indicate that the public cannot observe governmental employees and operations from a safe distance, either on private property or public property.

8-9-2: PENALTY:

Any person violating any of the provisions of this title shall be guilty of a class B misdemeanor, unless a different penalty is provided under state law, and shall be punished as set forth in title 1, chapter 4 of this code. If any violation be continued, each day's violation shall be deemed a separate offense.

SECTION 2: This ordinance took immediate effect upon posting the language on December 3, 2025.
