

City of Orem Resolution No. R-2025-0019

A RESOLUTION OF THE OREM CITY COUNCIL APPROVING AND AUTHORIZING  
THE MAYOR TO EXECUTE AN INTERLOCAL AGREEMENT WITH UTAH COUNTY FOR  
FUNDING OF IMPROVEMENTS ON CENTER STREET BETWEEN I-15 AND GENEVA  
ROAD

WHEREAS the City desires to construct improvements to Center Street between I-15 and Geneva Road (the "Project"); and

WHEREAS pursuant to Utah Code Ann. Section 59-12-1903 (2008) (now Utah Code Ann. Section 59-12-2218), Utah County adopted Ordinance No. 2008-26 to enact a sales and use tax (3<sup>rd</sup> Quarter Tax") of 0.25% upon certain transactions described therein; and

WHEREAS the Mountainland Metropolitan Planning Organization ("MPO") Board has determined that the Project should receive a portion of the revenues of the 3<sup>rd</sup> Quarter Tax not to exceed \$1,655,150 in 2026 and \$11,174,508 in 2028; and

WHEREAS the City desires to enter into an interlocal agreement with Utah County to set forth terms under which the Project will be designed, constructed, administered and funded; and

WHEREAS the Orem City Council finds that the proposed interlocal agreement is in the best interest of the City; and


WHEREAS the City Council desires to approve the interlocal agreement and to authorize the Mayor to execute said agreement.

NOW THEREFORE BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF OREM, UTAH AS FOLLOWS:

1. The City Council of the City of Orem hereby approves the proposed interlocal agreement with Utah County regarding the design, construction, administration and funding of the project to improve Center Street between I-15 and Geneva Road and authorizes the Mayor to execute said agreement substantially in the form shown in Exhibit "A" which is attached hereto and by reference is made a part hereof.

2. This Resolution shall take effect immediately upon passage.
