Director's report: Christy reported that the mid-cycle accreditation report has been completed and accepted. She reported that the financial audit of FY25 will be completed by November 30th. There was a State audit of the SPED department, both in operations and financially for the year cycle 2021-2023. That audit is now complete. Christy reported that current enrollment is 194 for in person and 97 for online, bringing the total number of students to 291. She reported they are launching a new pathway for next school year. Next semester Dixie Tech will be conducting an on campus App Development class for SGA High School students. Christy reported that they have their Thanksgiving Break, Winter formal, end of semester, and winter break coming up this semester.

School Safety and Student Wellness: Jodi reported that the graduation rate for last school year was 87.5% . She reported that the State of Utah is providing schools with 2-3 First Aid and bleed kits. Risk management has added a new policy to their existing insurance.

Enrollment and Marketing: Grace reported that on October 30th, they hosted their Candy Crusade Fall Festival. The event had food trunks, Spitfire hosted by Lighthouse Club, vendors and a trunk-or- treat. The event had an amazing turn out from the community. She reported that they are getting ready for enrollment in January and looking into dates for Open House.
