**1. CANVASS 2025 MUNICIPAL GENERAL ELECTION RESULTS**

Councilperson Peterson opened and welcomed everyone to the Special Council Meeting and introduced the first agenda item. City Recorder Jeff Nielson presented the final 2025 election results to the council. The results of the election are:

Mayor at Large:

- Cristy Simons 1596, 60.32%
- Matt Durkovich 1050, 39.68%

City Council Member at Large:

- Craig Sacco 1903, 41.51%
- Delys Snyder 1572, 34.29%
- Jonathon Watson 1109, 24.19%

The election results declare that Cristy Simons has been elected as Mayor at Large. Craig Sacco and Delys Snyder are declared elected as City Council Members at Large. The total voter information is 2659 ballots counted and 7068 total registered voters for a 37.62% voter turnout in this municipal election.


