A RESOLUTION DESIGNATING 911 AND INTERFACILITY TRANSFER AMBULANCE SERVICES FOR TOWN OF BRIGHTON

WHEREAS, the Town of Brighton has the responsibility to ensure timely, professional, and effective emergency medical services (EMS) for its residents and visitors; and

WHEREAS, Unified Fire Authority (“UFA”) has provided EMS services within the Town of Brighton, including 911 emergency ambulance response; and

WHEREAS, UFA provides for interfacility ambulance transfer service through a contract with Gold Cross Services, Inc.; and

WHEREAS, the provision of Advanced Emergency Medical Technician (AEMT) and Paramedic-level ground ambulance services, along with interfacility transport capabilities, is essential to the health, safety, and welfare of the community; and

WHEREAS, the continued licensure of Unified Fire Authority for Paramedic Ground Ambulance, AEMT Ground Ambulance, and Interfacility transport services ensures the Town can maintain and improve its emergency medical response capabilities; and

WHEREAS, the Utah Department of Health and Human Services requires formal support from the governing body of a municipality in applications for ambulance service licensure and re-licensure;

NOW THEREFORE, IT IS RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF BRIGHTON, UTAH, THAT:

Section I: Designation of EMS Provider. Unified Fire Authority is hereby identified and designated as Town of Brighton’s EMS service provider for 911 emergency ambulance services including Paramedic Ground Ambulance services, Advanced Emergency Medical Technician services, and Ground Ambulance services.

Section II: Designation of Interfacility Transport. Gold Cross Services, Inc. is hereby identified and designated as Town of Brighton’s interfacility transport ambulance service through its contract with UFA.


Section III: Commitment to Public Safety. Town of Brighton reaffirms its commitment to supporting Unified Fire Authority in providing high-quality EMS services to meet the needs of the community.

Section IV: Effective Date. This Resolution shall become effective upon passage and publication.
