**A RESOLUTION OF THE CITY OF TAYLORSVILLE, UTAH APPROVING
PARTICIPATION IN THE AMERICA250 UTAH COMMEMMORATION PROGRAM,
ACCEPTING A \$1,500 STIPEND IN RECOGNITION OF AMERICA’S 250TH
ANNIVERSARY**

WHEREAS, the Taylorsville City Council (the “Council”) met in regular session on December 17, 2025, to discuss, among other things, the approval of a partnership with America250 as stated herein; and

WHEREAS, the City of Taylorsville (“City”) is committed to fostering civic pride, historical awareness, and community unity through its annual Taylorsville Dayzz celebration; and

WHEREAS, it was brought to the attention of City staff an opportunity to collaborate with America250 Utah, the state-level initiative aligned with the national America250 Commission established to commemorate the 250th anniversary of the United States in 2026; and

WHEREAS, America250 Utah has invited the City of Taylorsville to participate in its statewide commemoration program and has offered a non-competitive stipend of \$1,500 to support approved community-based celebratory activities; and

WHEREAS, the City proposes to apply this stipend toward the procurement and distribution of miniature American flags along the Taylorsville Dayzz parade route, an activity harmonized with America250 branding and public-awareness efforts; and

WHEREAS, distributing flags during the parade is a longstanding and well-received tradition that symbolizes patriotism, unity, and appreciation of America’s founding values; and

WHEREAS, the successful execution of this initiative involves coordination among City staff, the Taylorsville Dayzz Committee, the Taylorsville Youth Council, and the Exchange Club, as well as collaboration with America250 Utah; and

WHEREAS, the City Council finds that the proposed activity and partnership with America250 Utah will contribute meaningfully to the statewide and national commemoration of the United States’ 250th anniversary and will enhance the community experience during Taylorsville Dayzz;

NOW, THEREFORE, BE IT RESOLVED by the Taylorsville City Council as follows:

1. The City formally approves participation in the America250 Utah commemoration program and accepts the \$1,500 non-competitive stipend offered to support this community initiative.

2. The City endorses the distribution of American flags during the 2026 Taylorsville Dayzz parade, incorporating America250-approved logos, messaging, and promotional materials.
3. City staff are authorized to coordinate with the Taylorsville Dayzz Committee, Taylorsville Youth Council, Exchange Club, and America250 Utah to plan, procure, and carry out all aspects of the initiative.
4. The City encourages residents' engagement in the upcoming America250 observance and supports efforts that promote civic pride and historical awareness.

This resolution, assigned Resolution No. 25-26, shall take effect immediately upon passage and acceptance as provided herein.
